PASS-THROUGH FOR WHOLESALE WATER RATE INCREASES

Any increases in the District’s wholesale cost of water service or water volume from Casitas MWD may be passed through on the District’s water volume rates for Zones 3 and 4. For example, if the District’s cost of wholesale water increases by \$0.10 per hundred cubic feet (hcf), then the District’s Water Volume Rate would also increase by \$0.10 per hcf in Zones 3 and/or 4. The District will provide written notice to customers in the affected zones prior to passing through any wholesale water rate increases. However, under no circumstance will the District’s water rates exceed the cost of service.

PURCHASED WATER SURCHARGE POLICY

When Lake Casitas water is purchased by VRWD in an amount that exceeds 1,000 hundred cubic feet (hcf) in any monthly billing period, a Purchased Water Surcharge (PWS) will be billed to customers. The PWS will only be charged to customers served well water and will be charged as follows: The PWS will be assigned to upper Cost Classes in Single Family Residential and Commercial accounts beginning with the usage in Cost Class 4 and then proceeding down to the lower Cost Classes until the quantity of water in the Cost Classes is greater than the quantity of water purchased. See the example below. The additional laboratory testing costs will be included in the PWS. The use of purchased water lowers electricity and disinfection costs so these saved expenses will be deducted from the PWS each month.

*Properties that need a ¾" meter for normal service but a 1" meter only for fire sprinklers shall pay the Capacity Charge for the ¾" meter. The minimum meter size in VRWD shall be ¾". Larger sizes shall be reviewed individually by the Board, and subject to available water supply, the Capacity Charge will be determined on the same basis.

Capacity Charge Costs were established in 1989 with an Engineering News Record Los Angeles Construction Cost index of 5,789.77 and adjusted to 2015 costs using the March 2015 index of 10,995.27.

ADDITIONAL DWELLING UNITS

Based on meter size in accordance with the Capacity Charge Schedule at a rate of 25% of the charge shown.
