SUBJECT: INVESTIGATION OF WELL #7 CONSTRUCTION

# SUMMARY

During the drilling of Well #7 the 24" Dia. Steel ODEX Drill Pipe got stuck and remained in the borehole. See the attached profile of Well #7. It is believed that the drill pipe is stuck up in the area of the sanitary seal where it is harmless. However the District's hydrogeologist Jordan Kear is concerned a piece of the drill pipe may have broken off and is hindering flow into the lower portion of the well.

A CITM electronic scan of the well should "see" the 24" mild steel drill pipe if it is indeed down at the bottom of the well. The cost to conduct a CITM scan is about \$6,250.

## RECOMMENDED ACTION

The General Manager recommends that the Board authorize the General Manger to have a CITM scan performed on Well #7 at a cost of about \$6,250 to determine if the Drill Pipe is a problem prior to accepting Well #7 from Jensen Well Drilling.

# <u>BACKGROUND</u>

Well #7 is a 16" diameter well. The well is not producing water as expected and it is believed that the lack of production is due to the inability to develop the well because of low groundwater water levels because of the drought. The plan has been to continue development work on Well #7 in the spring when groundwater levels rise.

On Friday Jordan Kear realized another possibility. When the 24# drill pipe got stuck in the well during drilling the lower portion of the drill pipe may have broken off unbeknownst to Jensen Well Drilling and may remain at the bottom of the well blocking the free flow of water into the well.

General Manager recommends conducting the CITM electronic scan of the well to verify presence or absence of the drill pipe prior to accepting the Well from Jensen Well Drilling. If the drill pipe is stuck in the well it is not known at this time what the solution would be for its removal. If the drill pipe is not a problem, the General Manager will recommend acceptance of the well in January.
