- 2) Engineering/Professional Services expense contains 54% of the cost of water system pressure maps and atlas. This project is at 94% complete.
- 3) Meter Replacement expense contains the cost of 6 ea. 3/4" meters.
- 4) Director Travel/Expense expense is a negative in the month due to reimbursement of CSDA travel expenses that were incurred in the prior period of March 2011.
- 5) Public Relations\Seminars expense contains the cost of Laserfiche training for the General Manager \$900.00 the balance is for training DVD's for Ethics and COBRA.
- 6) Equipment Rental expense contains the cost of a tractor rental for weed abatement.

ACCEPTANCE OF PIPELINE EASEMENT DEED ASSESSOR'S PARCEL NUMBER 033-0-350-235

James B. & Roberta A. Kerwin, Kerwin Family Trust 1991

SUMMARY

The District is interested in purchasing waterline easement through Mr. Kerwin's property so a pipeline can be installed from the Parker Booster Station to Valley Meadow Drive. This pipeline will provide pumping redundancy to the Alto Tanks and enable the District to lower the pressure on lower Valley Meadow Drive from 185 PSI to about 105 PSI on a pipeline that is old and at risk of failure.

Placing the pipeline through this easement saves the District about \$1 Million compared to other pipeline alignment alternatives.

The attached Right of Way Purchase Agreement describes the rights and responsibilities of both parties with regard to the purchase price of the easement and initial construction of the pipeline in the easement. A May 2011 appraisal for the easement placed the value at \$39,200.

RECOMMENDED ACTIONS

The General Manager recommends that the Board take the following action:

1. Authorize the Board President to sign the Right of Way Agreement and accept the waterline easement from Mr. & Mrs. Jim Kerwin.

BACKGROUND

The water main in Valley Meadow Drive is failing and needs replacing. Also the water distribution system needs pumping pipeline redundancy from the Parker Pump Station to the Alto Tanks. Through much investigation and alternatives analysis the District has determined that the lowest cost alternative is to install a water main from the Parker Tank Site through Mr. Kerwin's property.

At the June 8, 2011 Board meeting the General Manager and Attorney were directed by the Board to meet with Mr. Kerwin and present the appraisal and draft Right of Way Agreement. This meeting was held on June 14th and after completing

his review Mr. Kerwin indicated he is willing to dedicate the easement in a accordance with the Right of Way Agreement.

The Right of Way Agreement commits the District to repaving Mr. Kerwin's driveway when the pipe line construction is completed. The District would also install a new water service to Mr. Kerwin's home from the new water main. The agreement was amended to reiterate that Mr. Kerwin will be responsible for future maintenance of the water service after it is installed.

The property owner to the west of Mr. Kerwin does not have an easement over Mr. Kerwin's drive but does have an agreement with Mr. Kerwin that requires him to share in the cost of the driveway maintenance in exchange for use of the driveway. Therefore the District will not be required to obtain any easements from the neighbor. However during construction the District will need to reasonably accommodate the neighbor and Mr. Kerwin to minimize the access impact to their homes.

Mr. Kerwin indicated he did not see a need to go through an Escrow Agent to process this agreement and easement so the escrow portion has been deleted from the agreement.

The Board requested that succession language be added to the agreement because it may be 4 or 5 years before the District has adequate monies to install the pipes. Therefore the following language was added to the Agreement:

<u>"LIFE OF THIS AGREEMENT</u> - This agreement shall commence when signed and terminate on completion of construction and shall be binding upon all heirs, trust beneficiaries and assigns of Grantor herein."

FISCAL SUMMARY

The 2011/12 budget for the Valley Meadow Drive Project currently has a budget of \$60,000 in account # 91500042 for obtaining the easement. The completed cost should be about \$45,000, significantly under budget.

RIGHT OF WAY AGREEMENT

THIS AGREEMENT is made and entered into by and between **James B. Kerwin and Roberta A. Kerwin, as Trustees of the Kerwin Family Trust 1991** (hereinafter called "Grantor"), and the **Ventura River County Water District** (hereinafter called "VRCWD").

An Easement Deed covering the property rights particularly described therein has been executed concurrently with this Agreement and delivered to VRCWD representatives. A copy of said Easement Deed is labeled "Exhibit A" and is attached hereto and incorporated herein by this reference.

In consideration of which, and other considerations hereinafter set forth, it is mutually agreed as follows:

1. The parties have herein set forth the whole of their agreement. The performance of this Agreement constitutes the entire consideration for said Easement Deed and shall relieve the VRCWD of all further obligation or claims on this account, or on account of the location, grade or construction of the proposed public improvement.

2. The VRCWD shall:

- A. PAY to the order of the Grantor the sum of \$39,200.00 (Thirty Nine Thousand Two Hundred and No Cents) as consideration in full for the real property interests being conveyed in the referenced Easement Deed, for the loss, replacement and moving of any improvements, and for entering into this Agreement. Said sum shall be paid upon the recordation of the Easement Deed, which shall occur when title to said real property interests has vested in VRCWD free and clear of all liens, encumbrances, assessments, easements and leases, recorded or unrecorded, except for recorded public utility easements and public rights of way.
- B. <u>MISCELLANEOUS COSTS</u> Pay all title insurance, and recording fees incurred in this transaction.
- C. <u>CLEARANCE OF BONDS</u>, <u>ASSESSMENTS</u>, <u>OR DELINQUENT TAXES</u> Have the authority to deduct and pay from the amount shown in Clause 2. A. above any amount necessary to satisfy any bonds, demands, taxes due in any year except the year in which this easement records, together with penalties and interest thereon, and/or delinquent and unpaid non-delinquent assessments which have become a lien at the time or recordation.
- D. <u>PROPERTY RESTORATION</u> Generally preserve or restore the surface of the easement areas described in the referenced Easement Deed to the condition that existed prior to VRCWD's project construction, to the extent reasonably practical. VRCWD shall, upon conclusion of the pipeline,

- construction restore and rebuild the driveway with 2-inches of asphalt the full width of the disturbed driveway within the easement.
- E. <u>WATER SERVICE</u> Provide and install a new 1" water meter and service lateral from the main to the house connected to the pipeline with an operative pressure of about 55 psi.
- F. <u>INDEMNIFICATION</u> Indemnify, and hold harmless Grantor from any and all claims, damages, costs, judgments, or liability caused by VRCWD or its officers, employees or agents specifically arising from VRCWD construction and restoration work on Grantor's property or as a direct result of VRCWD's operation of VRCWD's facilities on Grantor's property.
- G. <u>RECORDATION OF INSTRUMENT</u> Accept the Easement Deed herein referenced and cause the same to be recorded in the office of the Ventura County Recorder at such time as when clear title can be conveyed to the VRCWD.

3. The Grantor:

- A. PAYMENT ON MORTGAGE OR DEED OF TRUST Agrees that any or all monies payable under this Agreement up to and including the total amount of the unpaid principal and interest on the note(s) secured by mortgage(s) or deed(s) of trust, if any, and all other amounts due and payable in accordance with the terms and conditions of said mortgage(s) or deed(s) of trust, shall upon demand(s) be made payable to the mortgagee(s) or beneficiary(s) entitled thereunder.
- B. <u>LEASE INDEMNIFICATION</u> Warrants there are no oral or written leases on all or any portion of the easement areas described in the referenced Easement Deed, or if there are any such leases, Grantor agrees to hold the VRCWD harmless and reimburse VRCWD for any and all of its losses and expenses occasioned by reason of any lease of said property held by tenant or Grantor.
- C. <u>PERMISSION TO ENTER PRIOR TO EASEMENT RECORDATION</u> Hereby grants to the VRCWD, its agents and contractors, permission to enter upon the easement areas described in the referenced Easement Deed prior to the recordation of the Easement Deed for the purposes of preparation for and construction of the VRCWD's facilities, subject to all applicable terms and conditions contained in this Agreement and the associated Easement Deed.
- D. <u>PERMISSION TO ENTER DURING CONSTRUCTION</u> Hereby grants to the VRCWD, its agents and contractors, a temporary construction easement

over APN 033-0-350-235 to construct the new water service to the grantor's home and to enable the installation of the water main within the 20-foot wide easement. The temporary construction easement shall begin with the start of construction and terminate at the end of construction.

E. <u>FUTURE MAINTENANCE OF NEW WATER SERVICE</u> – Acknowledges that after the VRCWD installs the new water service the Grantor shall be responsible for future maintenance of the service from his side of the meter to the home consistent with normal VRCWD policy.

4. The Parties agree:

- A. <u>PLANS</u> The attached Water Line Plan (Exhibit C) closely represents the agreed pipeline alignment within the easement.
- B. <u>LIFE OF THIS AGREEMENT</u> This agreement shall commence when signed and terminate on completion of construction and shall be binding upon all heirs, trust beneficiaries and assigns of Grantor herein.
- C. <u>ARTICLE HEADINGS</u> Article headings in this Agreement are for convenience only and are not intended to be used in interpreting or construing the terms, covenants and conditions of this Agreement.
- D. <u>COMPLETE UNDERSTANDING</u> This Agreement constitutes the entire understanding between the parties with respect to the subject matter hereof, superseding all negotiations, prior discussions, and preliminary agreements or understandings, written or oral. This Agreement may not be amended except in writing by the parties hereto or their successors or assigns.
- E. <u>VRCWD APPROVAL</u> This Agreement is subject to and conditioned upon approval and ratification by the VRCWD. This Agreement is not binding upon the VRCWD until executed by the appropriate VRCWD official(s) acting in their authorized capacity.

No Obligation Other Than Those Set Forth Herein Will be Recognized.

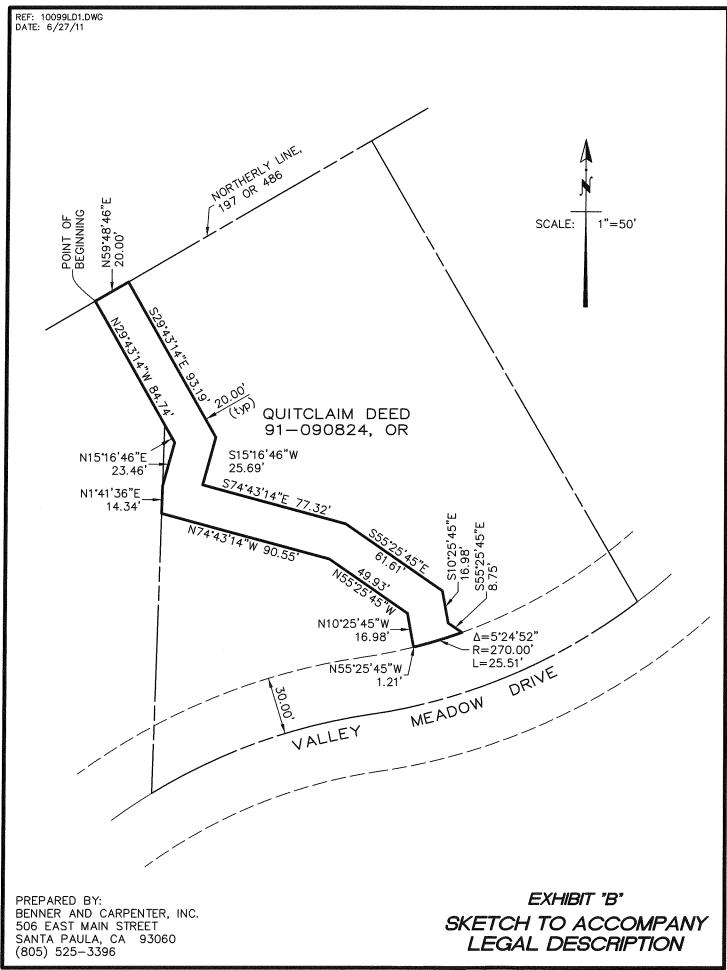

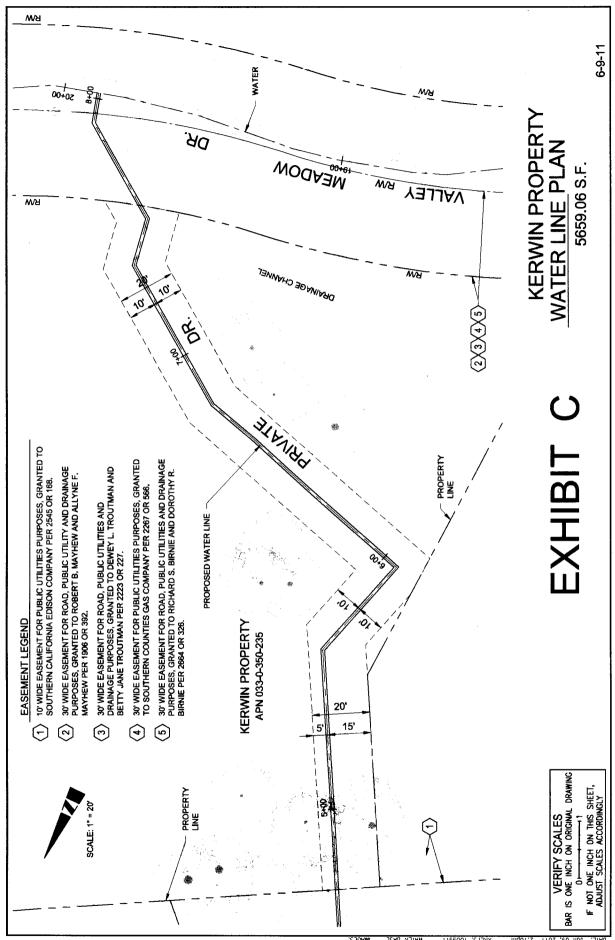

<u>Wells</u>

The static aquifer level at Well # 2 on June 1, 2011 was $\underline{21.3}$ feet below surface. The level has dropped $\underline{4.6}$ feet since the first of last month. The aquifer is currently $\underline{11.7}$ feet above the $\underline{21}$ - year average for May.

Production

Well # 1 is pumping 783 GPM down 10 GPM from last month. Well # 2 was not pumped this month. Well # 3 is pumping at 389 GPM down 2 GPM. Well # 4 is pumping 1122 GPM down 4 GPM. Total available well production: 2,780 GPM a decrease of about 20 GPM.

Supplemental Water was not utilized this month.

<u>Usage</u>

Sales dollars billed on July 1, 2011 amounted to \$112,056. Last year we billed \$120,427 during the same period. Water sold on June 30, 2011 amounted to 46,297 HCF, a decrease of -12.4% below the 52,830 HCF sold during the same period in 2010, and an increase of 2.4% above the 45,200 HCF sold last month (May 2011).

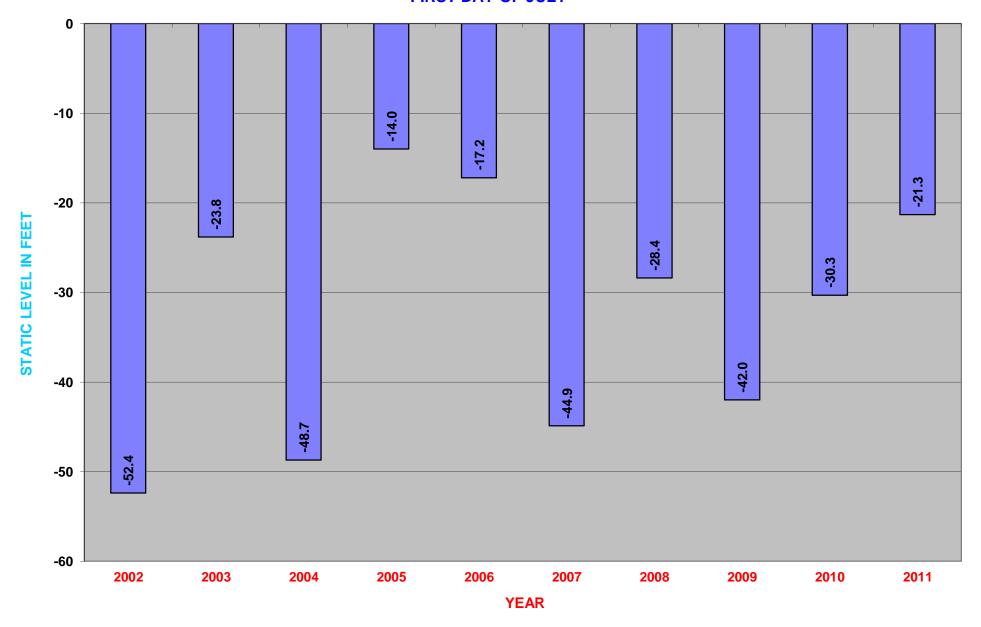

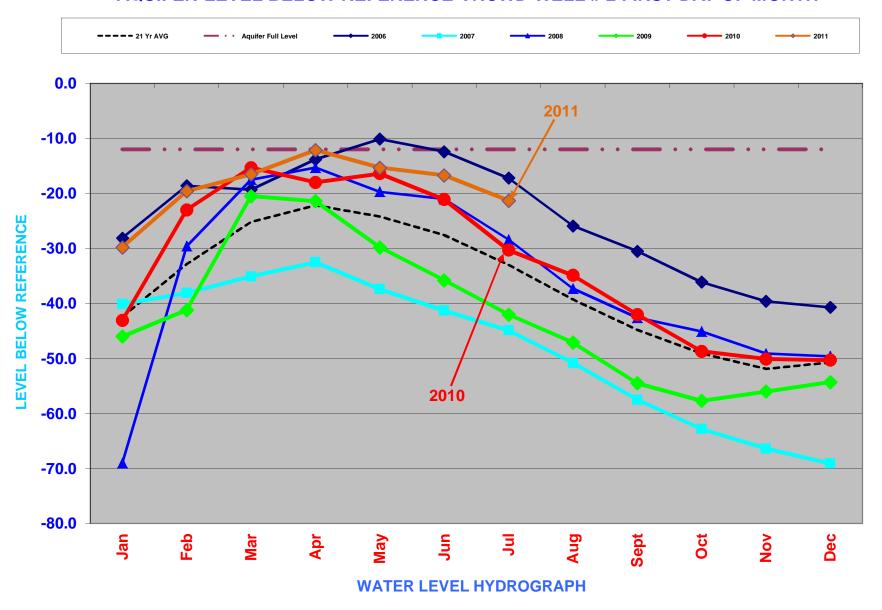

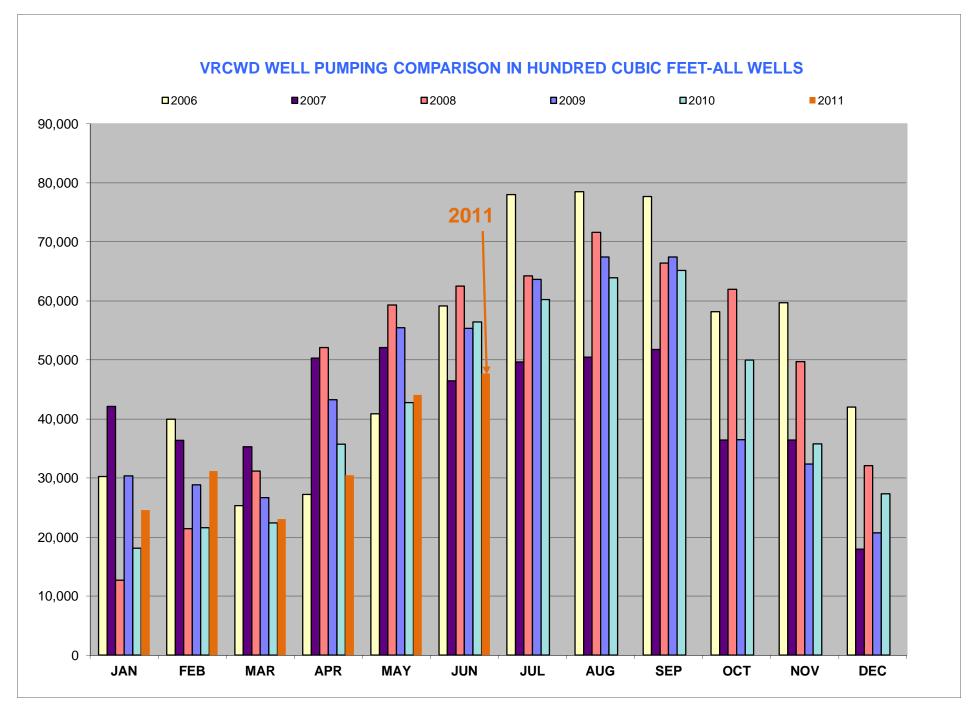
DEPTH OF WATER FROM SURFACE FIRST DAY OF JULY

Historical Annual Rainfall

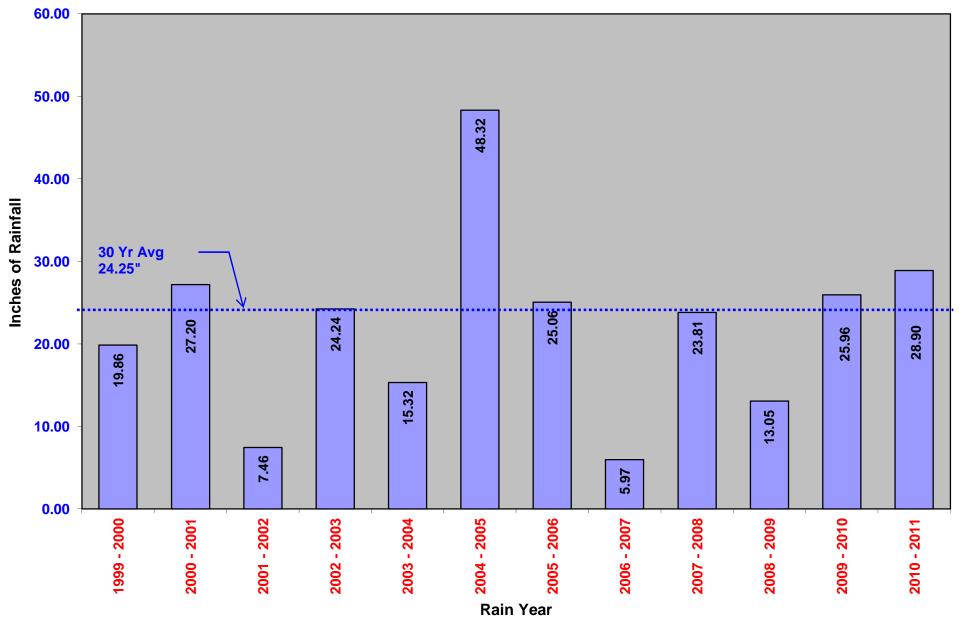


Chart 4 (Annual to Date)

DISCUSSION:

The average daily portfolio balance for the month of April amounted to \$ 2.2 billion. The portfolio yield for the month of April was .90%. The weighted average days to maturity increased 8 days to 371 days. The total net monthly earnings were \$ 1.7 million. The portfolio has been structured to satisfy the anticipated cash flow needs of the participants. The investment practices and portfolio holdings are in compliance with the current investment policy.

The portfolio has been managed with the stated objectives of safety, liquidity and earning a competitive rate of return, outlined in the Statement of Investment Policy. In striving to maintain the primary objective, safety of principal, the County portfolio has received a rating of AAAf by Standard & Poor's, the highest possible ranking given by the agency. Regarding the secondary objective, maintaining sufficient liquidity to meet cash flow needs, the portfolio is rated S1+, also the highest ranking given by S&P. In light of the first two objectives the portfolio has on balance outperformed its benchmarks, satisfying the final objective, that of earning a competitive rate of return.

Geopolitical events continued to unfold during the month causing the prices of stocks, bonds and commodities to rise during the month. In the U.S., the Fed reiterated its conviction to complete its so called Quantitative Easing program, where the Fed buys Treasury securities into its own portfolio causing rates to remain low. The Fed believes that this will cause funds kept in short-term assets to move to higher yielding alternatives and increase economic activity. Also, the unrest in the Middle East and economic issues in Europe, the U. S. and Japan have also caused funds to flow into commodities raising some concerns about the long term implications for inflation.

At the meeting of the Federal Open Market Committee (FOMC), the Fed's policy setting body, the committee elected to continue to keep the Federal Funds rate in a range from 0.0% to 0.25%. In the press release announcing the decision the FOMC provided this assessment:

Information received since the Federal Open Market Committee met in March indicates that the economic recovery is proceeding at a moderate pace and overall conditions in the labor market are improving gradually. Household spending and business investment in equipment and software continue to expand. However, investment in nonresidential structures is still weak, and the housing sector continues to be depressed. Commodity prices have risen significantly since last summer, and concerns about global supplies of crude oil have contributed to a further increase in oil prices since the Committee met in March, inflation has picked up in recent months, but longer-term inflation expectations have remained stable and measures of underlying inflation are still subdued.

With the Fed believing that inflation expectations are under control they have focused on their other mandate, higher employment, by attempting to increase economic activity. In the Beige Book, the report prepared for the FOMC by Fed staff that provides a broad overview of the nation's economic activity, the Fed got some welcome news and some things to worry about. In the report the Fed provided these observations:

- Economic activity generally continued to improve moderately with gains widespread across sectors
- Manufacturing continued to show steady improvement often with reports of increased hiring
- Retail sales remained weak but most areas showed at least slight gains
- Business services improved in most regions
- Residential and commercial real estate was generally flat to slightly improved
- While wage pressures were generally subdued higher commodity prices were putting increasing pressure on prices

It is these concerns about the possibility of higher prices that has caused some market participants to worry about the sustainability of the improvement in the economy. The fear is that higher prices may force the consumer to pull back which could stall the recovery. As a consequence rates were generally lower during the month with short-term rates down about 5 basis points and longer-term rates down 10 to 25 basis points.

Given the current interest rate environment we anticipate the County's yield to drop modestly. Further, we continue to seek investment opportunities in order to optimize earnings (U. S. Treasury Market graph attached).

Attached is a listing of market values provided by our custodian, Wells Fargo Bank, for all investments for the month ending April 30, 2011. GASB Statement no. 31 states that variances between the cost of investments and the fair value of investments shall not be considered budgetary resources or uses of resources unless the value of investments is permanently impaired because of decreased issuer creditworthiness or it is determined that the Treasurer be unable to hold investments to maturity. 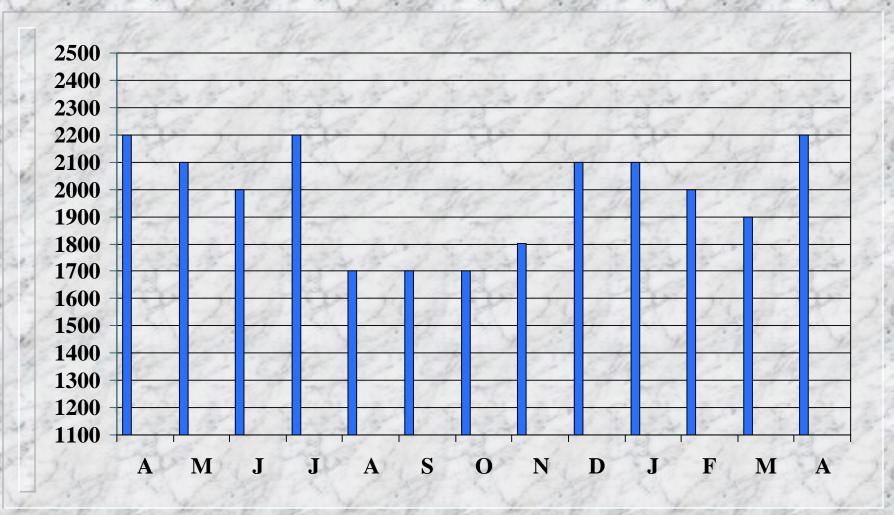
Exhibit 2 – Monthly Transactions

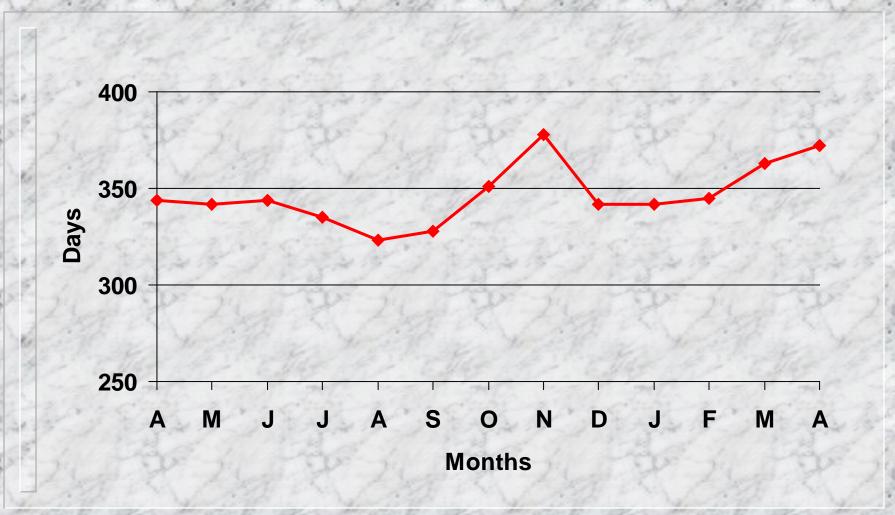

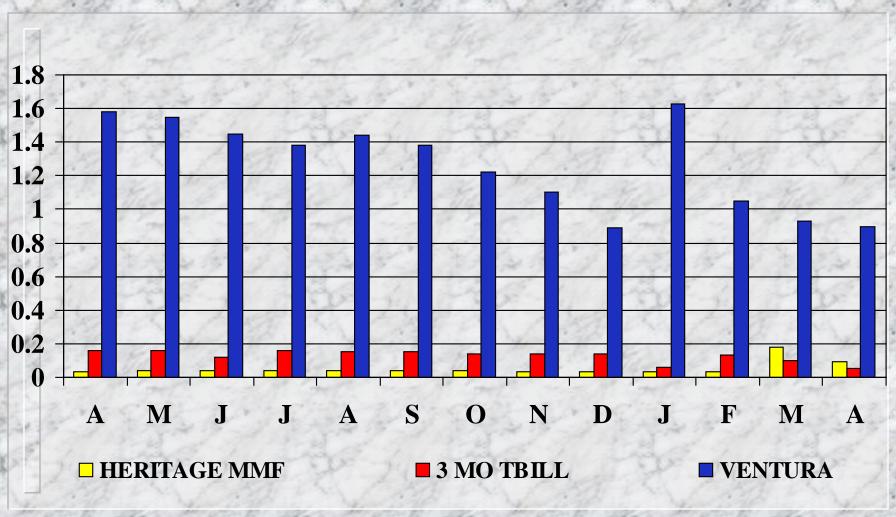
PORTFOLIO AVERAGE MONTHLY BALANCE



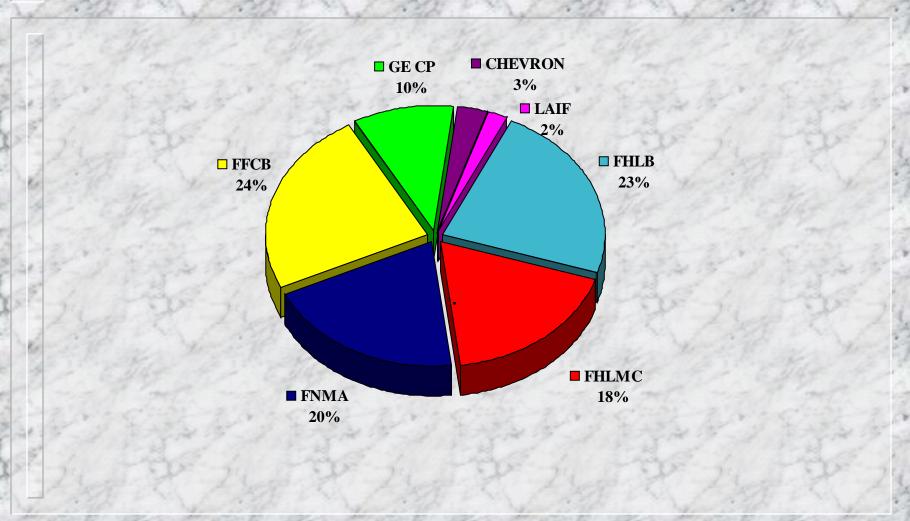
AVERAGE MATURITY



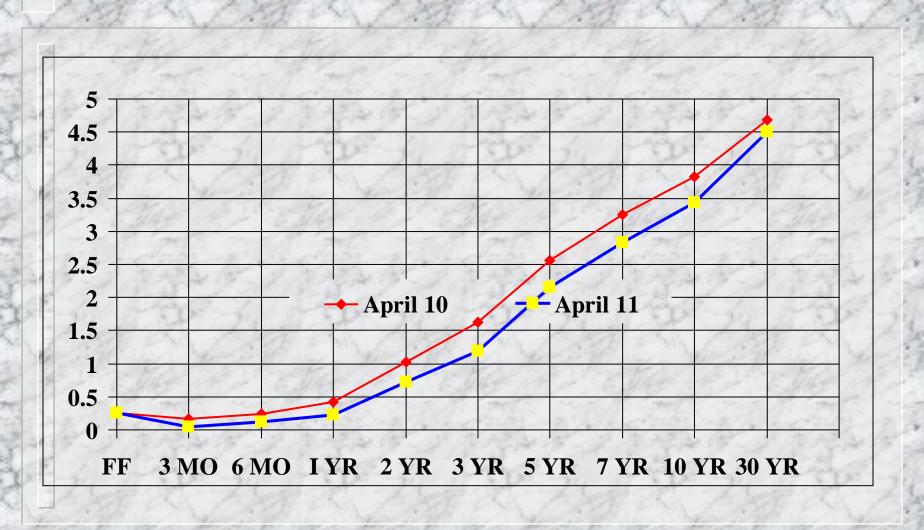

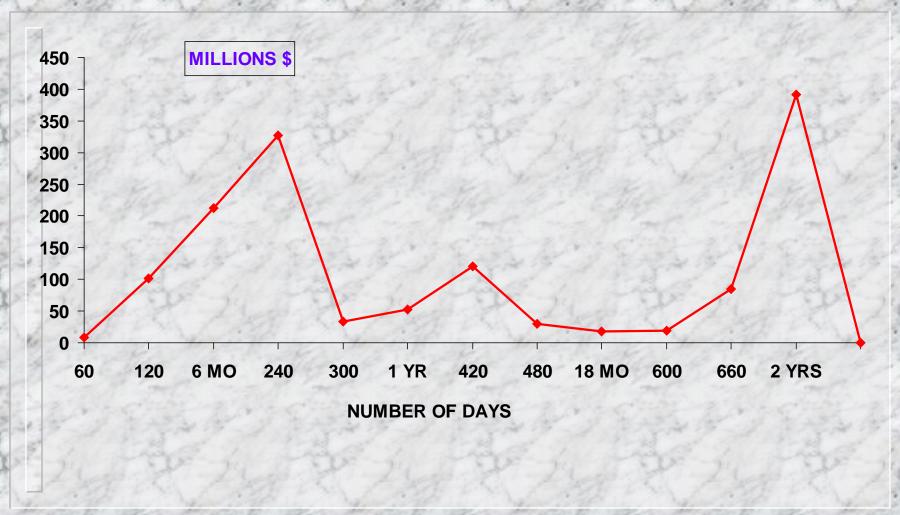
PORTFOLIO HOLDINGS'

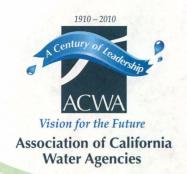


YIELD CURVE
