VENTURA RIVER WATER DISTRICT SPECIAL BUDGET WORKSHOP & TRAINING MEETING HELD APRIL 30, 2014

Pursuant to due and official notice, a special meeting of the Board of Directors of the Ventura River Water District was held at 409 Old Baldwin Road, Ojai, California on April 30, 2014.

Kuebler and carried. The Board also directed that funding also be provided for a second newsletter in the event that Casitas declare as drought emergency.
